**Old Business**

Addition to Complaint Form

At the committee’s last meeting in March it discussed adding language to the complaint form to help set the patients expectation when the treatment under complaint has been redone. Dr. Kane had offered to work with staff to draft a sentence to the complaint form. The committee reviewed the additional language presented “*Please be aware that any treatment done by the dentist in question, that is subsequently changed or redone by another dental provider, may affect the outcome of your peer review decision*”. The committee decided to change “the dentist in question” to “the dentist(s) in dispute”. Staff will make the updated change to the complaint form.

Finalize 2022 Peer Review & Ethics Workshop

The committee discussed the draft agenda for the October workshop and had some changes. Staff worked with Dr. Dexter to find cases that he and Dr. McGraw will present. Dan Schulte, the MDA Attorney, will speak on the legal aspects of the peer review process. Dr. Hostetler will do a follow-up with issues we are seeing in clinical reviews. Drs. Bartoszewicz, Cortis, and Matheson will perform mediation role play. They will present the do’s as well as the don’ts in mediation. Drs. Dexter, McGraw, Cortis, & Yancho will present examples of cases and the write-ups. There will be a box lunch for all attendees and the peer review meeting following the workshop. Staff informed the committee they have sent out the first invitation to all components and specialty peer review committees. They have scheduled to send additional follow up emails regarding the invitation. Staff will keep the committee updated on how many people have signed up to attend.
